RE: **INCORRECT HELD AWAY PAY**

Enclosed please find copy of correspondence directed to Myron Becker, Director, Labor Relations, in connection with incorrect payments made for held away in connection with a deadhead. The shortage was in excess of \$5.00 per hour.

Held away payments are based on the hourly rate of the last service performed. Attached hereto is the rate table. In order to find the hourly rate, take the daily rate and divide it by 8; this will give you the hourly rate. To find the minute rate, take the hourly rate and divide it by 60. This will enable you to compute the correct payment on a minute basis; thus you can determine what 4 hours and 23 minutes of held away payment is payable.

Please make this information available to the Membership, and advise them that they should check their held away payments when deadheading in separate service to make sure they're being paid the correct rate of pay.
